We may use a few of the side streets to stage parade participants, we'll will take advantage of this if it is needed. When you check in you will be given your parade entry number and map on where your group is to stage. Please be courteous to other participants and line up where directed.

The City expects the streets to be cleaned up after the parade so once again, to cover expenses, there is a \$25 clean up fee to participants that are handing out candy or flyers. This fee is to be paid in advance. If we do not receive a payment from you and you do pass out flyers or candy we will be sending you a bill. We will waive the clean up fee if your group will provide a clean up crew of 3 or more people armed with brooms, garbage bags, and/or leaf blowers, and a smile to help us clean up the street after the parade. Your clean up crew must check in with Laura Huntington or Pam Osborne before the parade starts at the judges area on Avenue A and First Street (near the gazebo). They will then be directed where to meet for the clean up service.

We are asking for your current email address so that we could send future applications via email.

# 2012 Official Entry Form Snohomish Easter Parade April 7, 2012

**Deadline for ALL Entries:** **March 30, 2012** (any entry received after this date will be placed at the end of the parade lineup). Mail entry to PO Box 135, Snohomish, WA 98291 or Fax to 360-568-3869.

**Time of Parade:** Sign-in from 9:30 a.m. at 1st & Lincoln Ave. Receive lineup number at that time. Lineup on First St. from Union Ave. to Lincoln Ave. Please line up where directed!!! The judges will be on the South side of the street at Avenue A. Trailers and cars should be parked West of Avenue D on First Street (across the street from the Visitor Information Center building).

Before filling out your entry form please note the following information:

## • Parade start time is 11:00 a.m.

- Send 1 representative to sign in for parade lineup number and location.
- Commercial entries enclose (any entry that displays a business name - only exception is little league and youth sports sponsor vehicles). Entry fee is \$25 for Snohomish Chamber members; \$35 for non-Snohomish Chamber members.
- Please remember to fill in the length of your unit (non-commercial entries are limited to 5 vehicles) number of persons in unit, and most appropriate category for your entry. (see below)
- Awards will be given for 1st, 2nd and 3rd place in each category, awarded immediately following the parade at the judges stand on the South side of First St. and Ave. A. (Please indicate whether you will be accepting your award if you win.)

**For the safety of our spectators please do not throw the candy or hand it out from any vehicles in the parade; candy and flyers must be handed out by going to the edge of the crowd (place the candy on the ground or hand it to an individual)! Our goal is to keep young children from running into the street for candy. There is a \$25 clean up fee that must be paid to the Chamber in advance.**
